# **California State PTA supports five state propositions**

California State PTA supports the following propositions on the November 8 ballot:

**Prop. 51: School Bonds. Funding for K-12 School and Community College Facilities.** Authorizes \$9 billion in general obligation bonds, with \$3 billion for new construction and \$3 billion for modernization of K-12 public school facilities, \$1 billion for charter schools and vocational education facilities, and \$2 billion for community college facilities.

**Prop. 55: Tax Extension to Fund Education and Healthcare.** Extends for 12 years the Prop. 30 personal income tax increases on incomes over \$250,000. Eightynine percent of the funding would go to K -12 schools and 11 percent to community colleges. Up to \$2 billion would be allocated to healthcare programs in certain years. School districts would decide how to spend the funding but would not be allowed to use it for administrative costs.

**Prop. 56: Cigarette Tax to Fund Healthcare, Tobacco Use Prevention, Research, and Law Enforcement.** Increases cigarette tax by \$2 per pack, with an equivalent increase on other tobacco products and electronic cigarettes containing nicotine, and allocates the funding to various healthcare programs and law enforcement.

**Prop. 58: Language Education Acquisition Readiness Now.** Repeals Prop 227 (1998), which prohibited the teaching of multiple languages in the classroom. It replaces the waiver process with a petition process, so parents can request a multilingual program or be allowed to transfer to another school that offers such curriculum. **Prop. 63: Firearms. Ammunition Sales.** Prohibits possession of large-capacity ammunition magazines, and requires their disposal by sale to dealer, destruction, or removal from state. Requires most individuals to pass a background check and obtain Department of Justice authorization to purchase ammunition. Includes other regulations for ammunition sales.

### Two education lawsuits come to an end in state Supreme Court

Two lawsuits dealing with education were tossed out by the California Supreme Court in August, bringing an end to six-year-old legal cases that attempted to change public school policy in the state.

The justices declined to hear **Robles-Wong v. California**, which claimed that California had a constitutional obligation to provide more funding for education, and **Vergara v. California**, which attempted to eliminate existing tenure, layoff and dismissal laws affecting teachers.

Both cases were denied in lower court decisions. Those decisions remain in place as a result of the Supreme Court's refusal to reconsider either matter.

Supporters of both cases say they will continue to pursue their efforts, either through legislation or renewed lawsuits.

# Four Resolutions approved at 2016 National PTA Convention

The following resolutions were approved at the National PTA Convention in Orlando, FL, this summer. The resolutions empower PTA at the National, State and local levels to take action on these issues.

**Electronic Cigarettes and Electronic Nicotine Delivery Systems (ENDS) and Youth.** E-cigarettes and other ENDS may contain nicotine, which is highly addictive and alters adolescent brain development. These products are marketed to young people and their use among students in grades 6 through 12 has tripled in one year's time. PTA supports measures to:

- Address the manufacturing and ingredients in ecigarettes and ENDS products.
- Prohibit sales and marketing to children under 18.
- Prohibit use in public places and schools.
- Educate youth, parents, school boards and local officials about the dangers of e-cigarettes and ENDS.

**Homework: Quality over Quantity.** Quality homework that is age appropriate can help students learn. However, high quantities of homework or work that relies heavily on parental input can add stress and harm family interactions, while not increasing academic achievement. PTA advocates for quality homework that motivates students based on grade and ability and evidence-based guidelines on homework assignments that are considerate of children's lives and family interactions.

**Recognition of Lesbian, Gay, Bisexual, Transgender and Queer/Questioning (LGBTQ) Individuals as a Protected Class.** All children and youth should be able to attend school in a safe and inclusive environment. PTA supports:

- Federal legislation that protects all children.
- Local action to prevent bullying.
