## Federal grants worth billions at stake

### Special leg session on schools

In an attempt to make California eligible for federal “Race to the Top” grants, Governor Arnold Schwarzenegger called for a special legislative session to push for statutory changes in education. Assembly Speaker Karen Bass created a Committee on Education, headed by Assemblywoman Julie Brownley, to spearhead those efforts. At stake is California’s part of \$4.3 billion in federal stimulus funds for schools.

One of the key issues under review is the repeal of an existing law that prohibits linking teacher evaluations to student performance; without this change, California will not qualify for “Race to the Top” funds. The Governor has also called for lifting the cap on the number of charter schools, allowing alternative pay schedules for teachers in some jobs, and opening enrollment to allow students to attend any school in the state.

The special legislative session will conclude before the end of the year.

### Accountability Progress Report shows student improvement

State Superintendent of Public Instruction Jack O’Connell was pleased to announce the seventh consecutive year of progress towards the goal of California schools achieving a score of 800 on the annual Academic Performance Index (API), with 42% of schools reaching that target.

The 2009 API report showed that while the achievement gap between Latino/African American and white/Asian students has narrowed slightly, it remains significant.

Progress declines at higher levels: While 48% of elementary schools have reached 800, only 36% of middle schools have done so, and the rate drops to 21% for high schools.

Results are based on statewide assessment results from the Standardized Testing and Reporting (STAR) Program and from the California High School Exit Examination (CAHSEE). *For the full report, go to [www.fourthdistrictpta.org](http://www.fourthdistrictpta.org).*
