Founders Day: A PTA history lesson

The National PTA (National Congress of Parents and Teachers) is a volunteer child advocacy organization with branches established in all 50 United States, the District of Columbia, U.S. Virgin Islands, and in schools for American dependents in Europe and the Pacific area.

Founded 115 years ago, on February 17, 1897, the National Congress of Mothers first convened in Washington D.C., gathering more than 2,000 volunteers to create a national organization dedicated to the welfare of children. On Founders Day, we remember the three founders of what is now known as the National PTA: Alice McLellan Birney, Phoebe Apperson Hearst, and Selena Sloane Butler. These women dedicated their lives to the primary purpose of uniting home and school into a planned program for child welfare. Mrs. Birney wrote, "In the child and in our treatment of him rests the solution of the problems which confront the state and society today."

Founders Day is a reminder of the substantial role that PTA has played locally, regionally, and nationally in supporting parent involvement and working on behalf of all children and families. It's a time to reflect and take pride in our many accomplishments, and to renew our commitment to be a powerful voice for all children, a relevant resource for parents, and a strong advocate for public education.

PTA's founders were women of imagination and courage. They understood the power of individual action, worked beyond the accepted barriers of their day, and took action to literally change the world. They had a simple idea—to improve the lives and futures of all of our children. As much as other conditions in America may have changed, that idea has not, because today's PTA keeps it alive.

PTA is now the largest volunteer child advocacy organization in the nation. Our members represent the diversity of our nation, and they come from the ranks of traditional families, single-parent households, blended families, grandparents, and other caring adults. Together, we continue to serve as the conscience of the country for children and youth.

PTA Purposes: Historical goals of PTA

- To promote the welfare of the children and youth in home, school, community, and place of worship.
- To raise the standards of home life.
- To secure adequate laws for the care and protection of children and youth.
- To bring into closer relation the home and the school, that parents and teachers may cooperate intelligently in the education of children and youth.
- To develop between educators and the general public such united efforts as will secure for all children and youth the highest advantages in physical, mental, social, and spiritual education.

PTA Mission: The overall purpose of PTA

- A powerful voice for all children,
- A relevant resource for families and communities, and
- A strong advocate for the education and well-being of every child.

California State PTA has partnered with Common Sense Media, a national nonprofit organization, to launch a new education campaign to combat cyberbullying. The new "Cyberbullying Toolkit for PTA Leaders: Stand Up, Don't Stand By" includes parent tip sheets, parent education videos, and other resources at www.commonsense.org/pta. This toolkit gives you what you need to organize a parent education night on the issue.

In all instances, make sure you work with your local school administrator to coordinate your efforts with their efforts to combat bullying.



Picture yourself as a PTA photographer

Have you ever noticed that the first thing you look at when you open a newsletter, magazine or a website is a photograph? With all of the information, news, and honors that PTA wants to share, photographs help us bring the story to life. Taking pictures is easy, fun and rewarding – especially when you see them in a school newsletter or on the PTA website. The best part is PTA wants your pictures!

Digital photography—whether we use our favorite camera or our smart phone – gives us freedom from film developing, freedom to edit pictures on-the-go, freedom to take hundreds of pictures at a time, and freedom to share them with everyone via newsletter or social media. Send your pictures, saved as a jpg, via your phone messaging system or from your home computer.

In the digital age, photos are taken everywhere and by everybody. Before you publish those photographs in your newsletter or on your website, double-check with your school office to make sure that parents have signed the release form allowing the school or PTA to use a child's image. Be cautious not to put in harm's way children who are in a family protection program; check with the parent before publishing. If your school does not have a release form on file for the child, go to the California State PTA *Toolkit*, page 362, to find a Photography Release form.

Have fun with photography in your PTA publications. Be cautious and make sure that parents have agreed to have their image or their child's image published. Using photographs in your publications generates excitement and enthusiasm. The old adage is still true: one picture is worth a thousand words.



Using technology to support student success

Integrating technology into core curriculum enhances learning by helping students acquire the skills they need to thrive in a complex, highly technological world. Incorporating technology in classroom instruction deepens learning through problem solving, active engagement, and team participation. Technology-integrated, project-based learning allows students to be intellectually challenged while providing them with a realistic experience of modern working environments. An added bonus is that using technology makes teaching and learning both meaningful and fun.

For the past ten years, the Orange County Department of Education (OCDE) has created an opportunity to highlight the innovative, replicable ways teachers integrate technology in the classroom, and to share the successes students achieve on a regular basis. The best student curriculum technology integration projects within Orange County schools are chosen to participate in the OCDE- sponsored Student Technology Showcase (STS), an anticipated component of the Orange County Computer Using Educators (OC CUE) Technology Festival and the statewide CUE Conference in Palm Springs, California. The Student Technology Showcase serves to inform parents, teachers, administrators, legislators, and higher education representatives about curriculum-based student technology projects being undertaken in public schools in Orange County.

To start the process, teachers complete an online application describing their student project, technology's role, and how teaching and student learning have changed as a result of the technology tools used in their classrooms. A volunteer review team made up of teachers, district technology coordinators, business/non-profit leaders, and OCDE staff read and rate each application and decide which projects merit a site visit. The site visits provide a hands-on opportunity for students to describe and demonstrate how they are using technology to learn specific content areas and how technology has been integrated into the learning process. The review team then selects the most innovative classrooms to present at the local and state level.

Another aspect of OCDE's STS process is the "dress rehearsal" held prior to the Showcase. This provides students the initial opportunity to present their projects in a science fair format to an audience of adults, and it gives the review team a final chance to select the projects that will represent Orange County at the statewide STS. In 2012, teams have an additional opportunity to be selected for the STS at the International Society for Technology in Education (ISTE) conference being held in San Diego in June.

This year, projects include the use of iPods and iPads to increase reading fluency and comprehension and to improve math, science, and other skills; Story Kit, an application that incorporates pictures, text and sound; blogs; video broadcasts and much more.

The Nominating Committee has met...now what?

The nominating committee has met, identified and contacted the most qualified individuals for each of the leadership positions on your PTA board, so now it is time to provide written notice to the membership of your PTA. This must be completed at least 30 days prior to the election meeting and can be done at an association meeting, or through a flyer or newsletter.

If one of the nominees withdraws before the election, the committee must meet immediately to agree upon another nominee. In the event that no qualified candidate can be found for a particular office, it is better to leave the office vacant than to fill it with a person not able to do the job. After the election, the board-elect may fill any vacant position, according to the unit bylaws.

The election of officers is held at an association meeting specified in the unit bylaws and will come under "new business" on the agenda. Each person on the committee must sign the Nominating Committee's Report, and this report, which includes the slate of officers, is read to the association by the chairman at the election meeting. At this time, nominations from the floor are also entertained by the president. The election of officers is then conducted by the president. Please refer to the *California State PTA Toolkit – Section 2.2 Nominations and Elections* for additional details regarding the election of officers.

As with most reports, the report of the nominating committee must be entered into the minutes of the association. Once this report is presented to the membership at the election meeting, the work of the most influential and powerful committee is complete.

Our Children, Our Future – Education Funding Initiative

A bold proposal to create a state trust fund dedicated to public schools has won the endorsement of California State PTA, which will participate in the signature gathering effort to qualify the measure for the November 2012 ballot.

The Our Children, Our Future Act would raise about \$10 billion in new revenues through a temporary sliding -scale income tax increase, with the highest income earners contributing the most. The revenue would be allocated directly to public schools on a per-pupil basis and would be used to provide a well-rounded education that supports college and career readiness for every student, promoting a high quality curriculum that includes the arts; music; physical education; science, technology, engineering and math (STEM); and vocational and technical education courses. It can also be used for smaller class sizes, school libraries and librarians, school nurses and counselors. Local parents, educators and staff would decide how the money is spent at each school.

Schools could use no more than one percent of the trust funding on administrative costs and would not be allowed to use the funds to increase salaries or benefits. The governor and legislature could not use the trust fund or direct how it is spent, and the revenue could not be used to replace Prop. 98 or any other current funding.

The proposal was developed by Molly Munger, a civil rights attorney and longtime education activist who is also providing financial backing for the project.

The measure must collect 504,760 signatures by April 20 to qualify for the November ballot. To assure that there are enough valid signatures, backers plan to collect 800,000, beginning in February.

El comité nominador ya se reunió, identifico y contacto a los individuos más calificados para sus posiciones de liderazgo en la mesa directiva, entonces ahora es momento de notificar a sus miembros. Esto debe hacerse al menos con 30 días de anticipación de la junta de elección y debe hacerse durante una junta de asociación y a través de una circular o en el boletín noticioso.

Si alguno de los nominados se retira antes de la elección, el comité debe reunirse inmediatamente para buscar un reemplazo. En caso de que no se pueda encontrar un candidato calificado para dicho puesto, es mejor dejarlo vacante que postular una persona que no hará el trabajo. Después de la elección la mesa directiva podrá encargarse de llenar la posición de acuerdo a lo estipulado por los estatutos. La elección de los oficiales se hace durante una junta de asociación y se debe poner dentro de "asuntos nuevos" en la agenda. Cada candidato debe firmar el reporte del comité nominador y dicho reporte, que incluye la lista de candidatos, se lee a los miembros por el director del comité. Al terminar, las nominaciones hechas desde el piso son mencionadas por el presidente. La elección de oficiales es conducida por el presidente. Vea la sección 2.2 de *La Carpeta de Recursos de la PTA de California*, que habla sobre la elección de los oficiales.

Como con cualquier reporte el del comité nominador es añadido a las minutas o actas. Una vez que el reporte es presentado a los miembros en la junta de elección, el trabajo de dicho comité se termina y se disuelve.

Nuestros Niños, Nuestro Futuro Iniciativa de fondo monetario para la educación

Una propuesta honesta para crear un fondo monetario para las escuelas públicas ha ganado el apoyo de la PTA de California, la cual participará en un esfuerzo para colectar firmas que calificaran a la propuesta para ser parte de la boleta de votación de Noviembre de 2012.

El acto Nuestros Niños, Nuestro Futuro se propone colectar 10 billones de dólares de nuevos ingresos a través de un aumento temporal de impuestos que se calculara de acuerdo al ingreso anual de las personas y con el que las personas que reciban más ingresos pagaran más. El ingreso de distribuirá directamente a las escuelas públicas en base al número de alumnos y será usado para proveer una buena educación que apoye la asistencia a la Universidad o a una institución técnica para desarrollar la carrera de cada estudiante, incluyendo un programa de estudio de alta calidad que incluya arte, música, educación física, ciencias, tecnología, ingeniería y matemáticas; además de proporcionar cursos de educación vocacional técnica. También el ingreso podrá ser usado para reducir el tamaño de las clases, crear bibliotecas con bibliotecarios además de consejeros,

Los padres, educadores y administradores de la escuela decidirán como se gasta el dinero.

Las escuelas no pueden usar más de un 1% de los fondos en costos administrativos y no se les permitirá usar dicho dinero para incrementar salaries o beneficios. La legislatura y el gobernador no podrán hacer uso de dichos fondos ni podrán decidir como gastarlos, además de que estos fondos no podrán ser utilizados para reemplazar la propuesta 98 o cualquier otro método de ingresos.

La propuesta fue desarrollada por Molly Munger, una abogada de derechos civiles y activista de educación que también está proporcionando el financiamiento de dicho proyecto.

La medida debe recolectar 504,760 firmas para el 20 de abril para poder ser sometida en la boleta de votación de noviembre. Para asegurarnos que tenemos suficientes firmas fidedignas, se planean recolectar un total de 800,000, empezando en febrero.

El 4o Distrito de PTA tomara un papel active en esta campaña estatal, empezando en un evento de inauguración el 15 de febrero. Todos los miembros de PTA están invitados a asistir. Venga a
