## Governor Brown signs or vetoes education bills

More than 700 bills landed on Governor Jerry Brown's desk after the end of the state legislative session on September 15.

About 40 of those bills are measures that California State PTA supports. The Governor has until October 15 to sign or veto each of the bills. If he does nothing, the bill automatically becomes law.

In September, the governor signed the following bills, which were supported by CAPTA:

- **AB 261** (Thurmond) High school students who are appointed to a school board must have preferential (advisory) votes in order to represent student opinions in the decision-making process.
- **AB 681** (Chau) The state Commission on Teacher Credentialing may determine that the academic and credentialing standards in specific countries are equal or greater than those in the U.S., allowing teachers from those countries to qualify for a teaching credential in California more quickly.

- SB 401 (Pan) This bill eliminates size restrictions on child care facilities in state office buildings and requires indoor and outdoor activity areas to conform to existing state regulations for child care facilities.
- SB 455 (Newman) This bill allows military families on active-duty orders to remotely enroll in any school district where they will reside regardless if the school is zoned to a military installation.

So far, the governor has vetoed two bills that were supported by PTA:

- SB 663 (Nielsen) This bill would have established standards for determining whether packages or labels of cannabis products are attractive to children. Gov. Brown said that current law already prohibit cannabis products from being designed to be attractive to children. State licensing authorities are drafting emergency regulations on packaging for the cannabis industry, which must take effect before January 1, 2018.
- **AB 1261 (Berman)** This would have required a school district to consider whether a mandatory expulsion or zero tolerance policy is deterring pupils from seeking help for substance abuse when developing its pupil suicide prevention policy. "I agree with the goal of this bill but believe this is a matter more appropriately handled at the local level," Gov. Brown said.

The Legislature adjourned on September 15 and will return to Sacramento on January 3.

# Time to visit your legislators

With the state legislature on recess until January, this is the perfect time to visit your state lawmakers in their local offices. Here are some tips before you go.

- **Determine the reason for your visit.** A small group of members from your PTA may want to introduce yourselves and talk about the relevance of PTA. If you have a specific issue, make sure it is something the legislator can address, rather than something that should be dealt with at the school district level.
- Call for an appointment. Specify how much time you will need and the reason for your visit.
- **Research the legislator.** Find out what bills he or she proposed or supported. Look for common ground.
- **Draft an agenda for your group** that includes an opening, introductions and an order of PTA issues to be discussed. Assign a role to each person, including leader and note taker.
- **Be respectful.** Dress in a business-like manner. Arrive on time. Listen to what the legislator says. Leave after your appointed time, unless the legislator continues the conversation. Build a positive relationship.
- **Present PTA positions.** Research those ahead of time. If you're not sure about an issue that comes up in the conversation, tell the legislator you will get back with the information. Personal positions should be communicated at another time.

## A new tool for arts advocates

CreateCA and the California Department of Education have launched an easy-to-use tool for parents, teachers and education leaders designed to help increase participation in arts education in California. The Arts Ed Data Project analyzes and reports school-level data on arts education courses in middle and high schools across the state. It is a way to identify and address education inequities in arts education.

The Data Project is a color-coded dashboard which allows users to review school-level, district, county and statewide data. For example, one is able to look up a child's high school and compare how many theatre classes, art, dance or music classes are offered compared to another high school in the district, or the state.

The Data Project also features a roadmap for districts that guides leaders through the process of examining their data to better understand their unique circumstances and challenges. Resources and helpful guides assist districts in assessing their programs and creating strategic arts plans.

Art advocates: look up the data for your district. Compare the data to other districts in the state. Talk to the leaders in your district regarding inequities that you may discover.

Arts education sparks creative thinking and helps students find success in college, career and in life. Now you have a way to advocate with data.
