# The future of the California high school exit exam is in question

As California transitions to a new testing system aligned with the Common Core State Standards, the future of the high school exit exam remains in question.

In 2013 state lawmakers passed AB 484, which suspended most of the testing requirements for California students. The California High School Exit Exam (CAHSEE), however, was not included and students continue to take it.

The exit exam, created in 1999, requires students to prove basic proficiency in math and English before they receive a high school diploma.

State education leaders are starting to discuss whether the exit exam should be required or not, and whether it should be revamped to meet Common Core Standards.

### Learn about education at Ed100.org

An effective advocate needs to understand how the California education system works. Becoming wellinformed can be a challenge, especially with the recent changes in curriculum and school finance.

Now you can easily learn everything you need to know through Ed100, a free online instructional course for parents who want to help improve their local schools.

Ed100 presents comprehensive information in 10 chapters, each divided into 10 brief lessons. Subjects include teaching, facilities, curriculum, school finance and testing. You can go through the lessons in order or pick the topics that are of interest to you. On-line interactive discussion boards provide opportunities to exchange ideas with other parents. The website is available in both English and Spanish.

PTAs can use Ed100 to help inform members and discuss critical education issues. The website also provides an Local Control and Accountability Plan Parent Checklist (look under the "About" tab) to help you participate in the planning process for your school district.

Ed100 is supported by a number of foundations. The primary author is Jeff Camp, a former Microsoft Corp. manager and chair of Education Circle. Longtime California State PTA leaders Mary Perry and Carol Kocivar contributed to the development of the project.

State Superintendent of Public Instruction Tom Torlakson has recommended several alternatives, including:

- Eliminating CAHSEE and using results of the new Smarter Balanced assessments to determine readiness for high school graduation.
- Using state tests along with voluntary exams such as the SAT or Advanced Placement tests instead of exit exams.
- Using the "successful completion" of specific courses to determine that students have met graduation requirements.

AB 484 requires the State Board of Education to present a comprehensive testing plan to the Legislature by 2016. Any changes in the testing program, including CAHSEE, will require new legislation.

# How to be an informed voter

The General Election is coming up on November 4. Now is the time to educate yourself on the candidates and issues, so you make the best possible choice as you vote. Read the candidate statements in the voter's pamphlet produced by the Registrar of Voters. Contact local candidates by phone or email and ask them about the issues that are important to you.

Here are some websites to help you be an informed voter:

#### • www.EasyVoterGuide.org

A nonpartisan guide that includes information on candidates, ballot measures, how to vote, important dates and useful resources, produced by League of Women Voters of California and the California State Library.

#### • www.SmartVoter.org

Nonpartisan information on elections and voting, with information about all state and local races and ballot measures. Produced by the League of Women Voters.

#### • www.FactCheck.org

A nonpartisan, nonprofit website that monitors the factual accuracy of what is said by major U.S. political players. Produced by the Annenberg Public Policy Center of the University of Pennsylvania.

#### • www.Maplight.org

A nonpartisan organization that provides information about money's influence on politics.

#### • www.ballotpedia.org

A collaborative encyclopedia about state politics, including elections, congress, state executive officials, state legislatures, recall elections, and ballot measures. Ballotpedia is a "wiki," which means anyone can add or change information, so caution is required.

#### Important Dates for the Nov. 4 Election

#### October 6 through 28

Applications for vote-by-mail ballots available from the Registrar of Voters.

#### October 28

Last day to deliver a vote-by-mail application to the Registrar of Voters.

#### October 20

Last day to register to vote in the General Election. Voter registration form must be postmarked or delivered to the Registrar by this date.
