The California Legislature has 120 lawmakers in two houses: 40 in the Senate and 80 in the Assembly.

The legislators are substantially outnumbered by the "third house" -1,871 registered professional lobbyists,

according to a recent article in the *Los Angeles Times*. Most of those lobbyists work for California cities, counties and statewide government associations, the *Times* said.

California State PTA (CAPTA) also has "lobbyists." Unlike paid lobbyists, PTA advocates are volunteers. They

work diligently to persuade legislators to pass laws that benefit children and public schools. (See the October 2015 issue of the *Communicator* for a detailed description of State PTA's process for selecting bills to support or oppose. You can find back issues at www.fourthdistrictpta.org.)

CAPTA has six advocates, two of whom proudly hail from Fourth District PTA: Donna Artukovic and Shereen Walter.

Needless to say, the six advocates have a huge job to do, with few resources. Perhaps their most important resources are YOU, the members of PTA. You can play a role in making sure that laws supporting the welfare of children are passed. You can do this by contacting your legislators whenever you get an action alert from Fourth District PTA or CAPTA.

In most cases, this can be done easily and quickly by sending an email to your state senator or assembly member or by making a quick phone call to his or her Sacramento office.

You don't need to talk to the legislator. Simply tell the staff person who answers the phone: "Hi, I'm Jane

The staffer may ask for your address to verify that you are a constituent. The phone call shouldn't take more than a minute.

Staffers tabulate the information they get from phone calls. According to Assemblyman Rocky Chavez, our Advocacy Forum speaker last May, "burning up the phones" with an organized campaign can definitely influence the voting decisions of legislators.

It's a good idea to know in advance the names of your senator and assembly member and how to contact them. Include their email addresses in your email address list. Program their phone numbers in your cell phone. That way you can act quickly when action is needed.

## The new two-year legislative session is underway

December 1 marked the beginning of a new two-year legislative session for California. The Senate and Assembly members spent the first few weeks organizing and electing officers before breaking for the holidays. The real legislative work begins in January.

In the first year of the session, lawmakers meet from the first Monday in January to mid-September and then recess until the following January. During the second year the legislature meets from the first week in January until November 30 of the next even-numbered year, when the session is adjourned.

When a bill is introduced in the Assembly or Senate, it must be approved by several committees in that house before a debate and vote by the entire house of origin. The bill then goes to the other house, where it again goes

through a committee process before a debate and vote by that house.

If the second house amends the bill and members of the first house do not concur with those changes, a conference committee of three Senators and three Assembly Members meets to iron out the differences. The new version must be approved by both the Senate and Assembly before being sent to the Governor.

The Governor can sign the bill into law or do nothing, which also enacts the bill into law. If the Governor vetoes a bill, the legislature has 60 days to override that veto with a two-thirds vote of both the Senate and Assembly.

#### Important legislative dates for 2017:

- Jan. 4—Lawmakers reconvene to begin legislative work.
- Jan. 10—Governor must submit a proposed State Budget
- Feb. 17—Last day to introduce a bill
- April 6 to 17—Spring recess
- June 2 —Last day to pass a bill out the house of origin June 15—State budget bill must be passed by midnight
- July 21 to Aug. 21—Summer recess.
- Sept. 15—All bills must be out of the Legislature and sent to the Governor
- **Oct. 15—**Last day for the Governor to sign or veto bills passed by the legislature
