# Now is a good time to start planning school board candidate forums

Many school districts will hold school board elections during the General Election in November.

PTA is non-partisan and never supports or opposes candidates for public office. However, PTA should be actively involved in helping voters make informed decisions on school board candidates. Many PTAs do this by hosting candidate forums.

Election information and vote-by-mail ballots will be mailed soon after the school year starts, so if your PTA intends to sponsor a candidate forum in the fall, the time to start planning is now.

Here are some things you can do to get ready:

Form a committee to organize the forum.

## Kevin Gordon will speak on the Governor's May revise budget

You won't want to miss the May California State PTA Advocacy Briefing when Kevin Gordon presents his insights on Governor Newsom's May revise budget.

Gordon is president of Capitol Advisors Group, an expert on the education budget, and a frequent speaker at PTA events. In February, he called the Governor's initial budget proposal "incredibly bold" and said it included substantial funding for programs long supported by PTA.

The May revise budget is based on updated tax revenue information. In January, the nonpartisan Legislative Analyst's Office predicted that revenues would be \$10.5 billion higher than the Governor estimated. This could lead to even more funding for public education.

The Advocacy Briefing will be held on Tuesday, May 24 at 7 p.m. It will be followed by an opportunity to speak with Legislation Team members, in small group settings, to ask questions and discuss effective ways to advocate at your school, district, and greater community.

# National PTA responds to President Biden's 2023 budget proposal

National PTA issued the following statement on President Joe Biden's budget proposal for Fiscal Year 2023:

"National PTA is pleased to see the Administration's FY23 budget proposal addresses long-standing educational inequities that were exacerbated by the COVID-19 pandemic as well as supports whole child learning and development. The proposal includes more than double the funding for Title I, which assists schools serving low-income families, and increases funding for the Individuals with Disabilities Education Act (IDEA)—the largest funding increases in two decades. It also includes \$1 billion in funding for school-based mental health supports and services in addition to increased investments in full-service community schools, which play a critical role in providing comprehensive wraparound services to students and their families.

"Our association has continuously advocated for improved mental health programs and services for children and families, including access to school and community-based mental health personnel and services. During final FY22 budget negotiations, we mobilized in support of the \$1 billion request. We are grateful for President Biden's inclusion of this crucial ask in his FY23 budget proposal as an urge to Congress and a signal to advocates nation-wide that we must come together as a nation to address the mental health crisis facing our youth. Robust and equitable investments in our public education system as well as solutions to ensure the needs of the whole child are met are essential to make sure all children can begin to recover from this pandemic and reach their fullest potential.

"Our association also appreciates the continued investments included in the proposal for the Statewide

### The top-two open primary election

California has a top-two open primary system of voting for candidates running for partisan offices, including U.S. senator, U.S. representative, governor, lieutenant governor, state senate and assembly, and several other state offices. All of the candidates for these positions are on everyone's ballot, and you can vote for any of them. The two candidates who receive the most votes, regardless of party affiliation, will advance to the General Election in November.

Your ballot also includes nonpartisan offices: Orange County Superintendent of Schools, Orange County Board of Education, county supervisors, Superior Court judges, and other county offices. The candidate for each position who receives a majority of votes in the Primary is elected to office. If no candidate wins, the two candidates with the most votes proceed to the General Election.

#### Get ready for another year of advocacy

Advocating for children, families and public education is central to PTA's mission. Be sure your PTA is ready to participate in this important role next year.

- Make sure your PTA picks an advocacy representative. This can be an elected office or an appointed chair position.
- Include advocacy in your PTA budget for next year.
- Plan to send a representative to Sacramento Safari, scheduled for February 27 and 28, 2023. Include about \$700 in your PTA budget for the trip.

#### **COVID** vaccine mandate on hold

California students will not be required to be vaccinated against Covid-19 for the 2022-33 school year, according to the California Department of Public Health (CDPH). The mandate cannot be put into effect because the federal Food and Drug Administration has not fully approved COVID-19 vaccines for children in 7<sup>th</sup> to 12<sup>th</sup> grades. The FDA has approved the vaccines for emergency use only.

According to a CDPH press release, upon full approval by the FDA, CDPH will consider the recommendations of the Advisory Committee on Immunization Practices of the United States Centers for Disease Control and Prevention, the American Academy of Pediatrics, and the American Academy of Family Physicians prior to implementing a school vaccine requirement.

SB 871, which would have required students to receive a COVID immunization and eliminated exemptions for personal beliefs, has been put on hold by its author, Senator Richard Pan. California State PTA did not take a position on this bill.
