State budget continues to support education priorities

Californian schools are starting the 2023-24 year with a strong education budget.

Although it doesn't match the record-breaking budgets of the last three years, the \$95 billion allocated to K-12 schools continues to support priorities and programs that were initiated during the last several years.

Budget highlights include:

- An 8.2 percent cost of living increase.
- \$4.4 billion for community schools.
- \$4 billion for after-school and summer programs for low-income children.
- \$3.3 billion for the arts, music and instructional grant program. (This is in addition to nearly \$1 billion in Prop. 28 arts funding.)
- \$5.9 billion for learning recovery block grants.
- \$500 million for the Golden State Pathways program, which promotes career opportunities for low-income high school students in high-skill, high-wage fields.
- \$300 million for the "equity multiplier" program that will provide additional funding to schools with the highest concentrations of students who

Grand Jury reports on children's issues

The 2022-23 Orange County Grand Jury issued several <u>reports</u> of interest to advocates for children.

- Russian Roulette: Fentanyl in Orange County "In Orange County, fentanyl related deaths have increased from 37 deaths in 2016 to 717 deaths in 2021, with fentanyl being the leading cause of death in coroner-related cases for kids 17 and under in 2021."
- School Shootings: How Prepared are Orange County Public Schools? "Based on its investigation, the Grand Jury believes that Orange County public school districts are doing a good job in attempting to maintain safe and secure campuses for their students. However, there is always room for improvement."
- The ABC's of Educating Children Experiencing Homelessness in Orange County "There are over 23,000 homeless children in Orange County as reported by the public school system, and more than 30,000 according to a number of nonprofit organizations and subject matter experts."

are low-income, English learners, homeless, or in foster care.

- \$250 million in one-time funding to train and hire literacy coaches at high-poverty schools.
- \$80 million to expand programs at juvenile court and alternative schools.
- \$20 million in professional development grants for bilingual teachers.
- \$3.5 million to provide opioid overdose reversal medication at all middle and high schools.
- \$1 million to create a list of screening instruments schools can use to identify students at risk for dyslexia and other reading difficulties, beginning in 2025-26.
- \$2.8 billion to subsidize child care for lowincome families.

The state budget is based on the governor's and legislature's estimates of how much money the state will collect through income taxes. The state's nonpartisan Legislative Analyst's Office is less optimistic about that amount and forecasts \$30 billion less in revenues. "The state will very likely face more budget problems over the next few years," the LAO predicts.

What are state lawmakers doing?

California senators and Assembly members are completing their work for the year. September 8 is the last day they may approve amendments to bills. The last day for each house to pass bills is September 14. The legislative session ends on that day. The governor has until October 14 sign or veto bills passed by the legislature.

The lawmakers will reconvene on January 3.
